PURPOSE

The purpose of this report is to appoint additional community representatives to the Interim Independent Advisory Assessment Panel and the Local Planning Panel to be established under Part 2, Division 2.5 of the *Environmental Planning and Assessment Act 1979*. The report also seeks to appoint additional expert members to the Interim Independent Advisory Assessment Panel and also alter the Council representatives on the Southern Region Planning Panel.

BACKGROUND

At the meeting held on 24 March 2021, Council resolved to establish a Local Planning Panel (LPP) for Wingecarribee Shire Council in accordance with Part 2, Division 2.5, Section 2.17 of the *Environmental Planning and Assessment Act 1979* to consider:

- a) All development applications ordinarily referred to Council for a decision and applications and matters required to be reported to a LPP as prescribed in the Local Planning Panel Direction – Development Applications and Applications to Modify Development Consents
- b) All Planning Proposals and make recommendations to the Council with regard to the merits.

At this meeting Council also resolved that until a Local Planning Panel is formally established by the Minister for Planning and Public Spaces, an Interim Independent Assessment Advisory Panel be established.

At the meeting on 26 April 2021 as a part of the Interim Administrator's Minute, Council resolved that the Acting General Manager immediately commence the process of expanding and refreshing the community representation base of the Interim Independent Advisory Assessment Panel and the Local Planning Panel (once established).

Council undertook further advertising and promotion for a period of 20 days to seek community representatives for the Interim Independent Advisory Assessment Panel / Local Planning Panel.

In response to Council's advertisement period between 31 March 2021 and 19 April 2021 a total of thirty four (34) submissions were received from the community.

A selection panel comprising of the Acting General Manager, Acting Deputy General Manager and the Group Manager Planning, Development and Regulatory Services reviewed all nominations received.

The Panel recommended the following community members community representatives to the Interim Independent Advisory Assessment Panel / Local Planning Panel until 1 February 2024:

- William (Bill Davidson)
- Robert Staas
- Denis McManus
- Anthony Geoffrey Neill

The appointed community representatives will be programmed / rostered to the panel in accordance with the established operational guidelines.

In order to increase the number of experts appointed to the Interim Independent Advisory Assessment Panel to ensure an appropriate quorum should panel members have conflicts of interest, it is proposed to increase the number of independent panel experts from 4 to 6. The increase in independent experts will also ensure consistency with the level of expert membership of other local planning panels operating within the Sydney Metropolitan areas.

Accordingly, it is proposed that Linda Kelly and Brian McDonald be appointed independent experts to the Interim Independent Advisory Assessment Panel. Both experts are highly experienced town planners and Brian also has qualifications in architecture and heritage which will provide additional expertise to the panel.

Given the suspension of the elected Council by the Office of Local Government, Council currently does not have any Councillor membership on the Southern Region Planning Panel. In order to address this, it is proposed that the current Local Planning Panel chair and alternate chair members be approved by the Minister be appointed as Council's representatives to the SRPP until February 1, 2024.

To ensure consistency between the Local Planning Panel and also the Southern Region Planning Panel, it is proposed that the community representatives appointed to the LPP also be appointed to the SRPP. These proposed changes will increase the membership of the community representation for the SRPP from two (2) members to six (6).
