Re: Bowral South Masterplan Brief

I am writing on behalf of the WinZero Board regarding the agenda item on the Bowral South Master Plan brief. We are deeply concerned about the lack of attention given to the provision of a town centre with local services in the plan. With a projected population of 1500 homes a traditional town centre would be viable in this location.

In this Shire it is imperative to move away from conventional subdivision with its typical lack of consideration for the social and economic wellbeing of future residents and deliver growth that will compliment the well established character of the Southern Highlands.

Moreover, the absence of references to walkability and genuine sustainability is alarming. The foundation of genuine sustainability is achieved through access to local goods and services. It is imperative to have the majority of people within walking distance, ideally 400-500 meters, from the centre. The provision of local services in the town centre enables an increased density in and near the centre and would significantly reduce the number of trips to Bowral town centre which is already choked with traffic.

We believe that the project control group should include two skilled citizens who are motivated in social, economic, and environmental sustainability. Without this there will be little achieved with public engagement. Innovation cannot be expected solely from Council staff and landowners.

It is a crucial moment for the Shire with such a landmark site to consider these opportunities, and a more refined analysis of road layouts and parks will not deliver the desired walkable neighbourhoods or town centres.



Furthermore, we believe that the brief should be revised to include the option of a town centre in the design. It is a major deficiency that no consideration has been given to this option. A town centre in this location would also advantage existing residents in East Bowral.

In conclusion, we request the Council to consider the importance of a town centre in the Bowral South Master Plan and arrange a meeting with WinZero representatives with yourself, the General Manager and the Strategic Planner to discuss this pressing and urgent matter. We are clear in our understanding that residents do not want more car dependent sprawl in our new greenfield development as outlined in the attached survey we conducted recently.
