1.1 Bowral Memorial Hall Refurbishment – Temporary Works Zone

PURPOSE

To seek approval to install a temporary works zone on Bendooley St, Bowral for the duration of the major refurbishment of the Memorial Hall.

RECOMMENDATION

<u>THAT</u> R5-25 Works Zone signs be installed outside the frontage of Bowral Memorial Hall on Bendooley Street, Bowral for a duration of approximately 12 months.

REPORT

BACKGROUND

Bowral Memorial Hall refurbishment is due to commence in the near future. This is a major Council capital works project and in total the construction is estimated to take at least 12 months. In order to facilitate safe construction loading / unloading and short-term parking, a work zone is proposed outside the frontage of the memorial hall on Bendooley Street.

<u>REPORT</u>

As shown in Attachment 1, the proposed work zone will replace about four (4) on street spaces currently signposted 1P 9.30am-6pm Mon-Fri 8.30am-12.30pm Sat.

This area of Bendooley Street is an area of high pedestrian activity with a preschool, the civic precinct and various other trip generators in close proximity. Therefore maintaining safe access for pedestrians during the works is of high importance. As shown in the traffic control plan (Attachment 2), a traffic controller will be present to manage pedestrian / vehicle conflict when the driveway is in use. After consultation with Council, the contractor has also agreed to undertake concrete pours from within the site to avoid closure of the footpath. Access to the civic precinct courtyard and parking area is available at the back via Short St, therefore signage will be erected for the duration of the works to direct customers to the alternative access.

The DA Conditions for the refurbishment of Bowral Memorial Hall permit construction work from 7am-5pm Mon-Sat therefore the Works Zone hours of operation will align. Outside of these hours unrestricted parking will be permitted (except across the driveway).

A Works Zone is proposed outside the frontage of Bowral Memorial Hall to facilitate safe loading and short-term construction vehicle parking.



Install R5-25 Works Zone signs for a distance of approximately 36m commencing at existing driveway.


