

5 DECLARATIONS OF INTEREST

6.1 **PROJECT 24 - Contract Negotiation Report - Receival, Processing** and Disposal Services for Municipal Waste and Resource Streams

PURPOSE

The purpose of this report is to inform Council of the Contract negotiation outcome undertaken as part of 'Project 24' for the receival, processing and disposal of municipal waste and resource streams.

OFFICER'S RECOMMENDATION

THAT:

- 1. Council receives the confidential Negotiation Report (Negotiation Report) at Attachment 1 regarding the receival, processing and disposal services of municipal waste and resource streams.
- 2. The Negotiation Report be withheld from access to the media and public as required by Section 11(2) of the Local Government Act 1993 for the following reason:
 - a. The Report is confidential in accordance with s10A(2) of the Local Government Act, 1993, under clause 10A(2)(c) - it contains information that would, if disclosed, confer a commercial advantage on a person with whom the council is conducting (or proposes to conduct) business.
- 3. Following the successful negotiation of service agreements in accordance with the resolution of Council in October 2022 and pursuant to s. 178 (3) (e) of the Local Government (General) Regulation 2021:
 - a. Council enters into an agreement with Veolia Recycling & Recovery Pty Ltd (ACN 002 902 650) for the following receival, haulage and processing services for municipal waste and resource streams for an initial term of 5 years and 1 month:
 - i. receival and haulage services for mixed waste,
 - ii. receival and processing services for bulky waste,
 - iii. receival and processing services for recycling, and
 - iv. receival and processing services for garden organics; and

- b. Council enters into an agreement with Cleanaway Pty Ltd (ACN 000 164 938) for the receival and disposal services for mixed waste for an initial term of 5 years.
- 4. The General Manager be authorised to execute the relevant contract documents.
- 5. Soil Co Pty Ltd is notified as appropriate that their offer was not accepted.

REPORT

BACKGROUND

Wingecarribee Shire Council, as well as the neighbouring Councils of Camden, Campbelltown City, and Wollondilly Shire (the Councils), provide waste management services to their communities. The disposal and processing of municipal waste and resource streams is managed by the Councils through a service contract. The current disposal and processing service arrangements have been managed through a contract that is due to expire on 31 May 2024.

Campbelltown City Council on behalf of the Councils, invited tenders for the receival, processing and disposal services through a public tender process in August 2021. The tender period closed on 3 May 2022.

The services requested for Tender RFT T21/13 Receival, Processing and Disposal Services for Municipal Waste and Resource Streams were for the following waste streams:

- Part A Garbage and bulky clean up waste
- Part B Recycling
- Part C Organics

Conforming Tenders from the following organisations were received by the closing time:

- Cleanaway Pty Ltd (Cleanaway)
- SOILCO Pty Ltd
- SUEZ Recycling and Recovery Pty Ltd (SUEZ)

Note- that during the tendering process SUEZ Recycling and Recovery Pty Ltd (SUEZ) was acquired by VEOLIA Pty Ltd.

A non-conforming tender was received from Bingo Waste Services and was assessed in accordance with the Tender Evaluation Plan.

The Project 24 team consists of a Project Working Group comprising the senior waste management officers, and a Project Control Group (PCG) which contains the Chief Executives or their delegates, from each of the participating Councils.

The key objectives of the tender were to:

- i. ensure that the services are delivered in a manner that is effective, flexible, efficient, economical and sustainable;
- ii. ensure that the services are able to adapt to changes in industry standards, respond to technological advances and reflect community expectations;
- iii. achieve sustainable systems of waste management services;
- iv. to encourage circular economy in the region with regard to end markets for recovered waste materials;
- v. maximise resource recovery and reduce waste to landfill;
- vi. align with the NSW Waste and Sustainable Material Strategy 2041;
- vii. provide cost-effective and value for money services with price certainty for the term; and
- viii. ensure continuity of service provision over the term.

The Tender Evaluation Report was presented to the Extraordinary Meeting of Council (11 October 2022) where the recommendations to decline all tenders and enter into negotiations with the Nominated Persons was resolved under Resolution MN2022/22.

<u>REPORT</u>

Following the Council resolution to decline to accept tenders and enter into negotiations with Nominated Parties, the Councils developed appropriate protocols and plans to guide the negotiation process.

A Negotiation Protocol was developed in conjunction with the Project Probity Advisor O'Connor Marsden and Associates (OCM), to establish the guiding principles for the negotiation process.

In November 2022, the Councils commenced the negotiation process by inviting the Nominated Persons identified through the tender process as having the most suitable likely solutions for the Councils to enter negotiations.

The Councils conducted the negotiations through a number of methods, including:

- I. establishment of governance arrangements through the formally constituted Project Working Group, together with the Project Control Group in order to identify agreed responsibilities, roles and reporting requirements for the Councils;
- II. settling a negotiation strategy setting the objectives, and documenting all practical arrangements, for the negotiation process;
- III. adopting the negotiation protocol, setting out the processes for all interactions and to guide the negotiations;
- IV. obtaining expert advice as required.

The Councils noted that the offers from Veolia present the most suitable and value-for-money services, together with the mixed waste disposal services offered by Cleanaway. The location of the Veolia Spring Farm facility was central to the Councils' considerations and offered the most suitable solution for the region.

The following options were agreed by the Councils as follows:

- I. Mixed waste to be received at the Spring Farm facility and transferred by Veolia to be disposed of to landfill at Lucas Heights operated by Cleanaway.
- II. Bulky clean up waste to be received at the Spring Farm facility and transferred by Veolia to be processed for resource recovery at a facility in Cecil Hills operated by Brandown Pty Ltd.
- III. Recycling to be received and processed at the Spring Farm facility by Veolia. This arrangement includes the Councils and Veolia sharing the risks on the revenue gained by Veolia for the output commodities such as paper, metals and plastics.
- IV. Garden organics to be received at the Spring Farm facility and transferred by Veolia to be processed by Australian Native Landscapes Pty Ltd from their facility at Badgerys Creek.
- V. The agreements to be for a term of 5 years and 1 month.

Both agreements with Veolia and Cleanaway are proposed to be for an initial term of 5 years and 1 month. The contract term will allow the industry time to respond to the current infrastructure challenges and allow the organics industry to upscale the processing capacity within the Sydney area to transition to FOGO processing and meet the capacity demand in line with the NSW Government's Waste Strategy.

This would also allow the Councils to retender for services after NSW plans for Energy from Waste infrastructure have been further developed, giving industry more certainty.

The details of the commercial negotiation, including pricing, are provided in the confidential Negotiation Report attached to this report. The Probity Advisors Report for the Project 24 negotiation process is provided at attachment 6.1.2 to this report.

COMMUNICATION AND CONSULTATION

Community Engagement

No Community Engagement has been undertaken as part of this project.

Internal Communication and Consultation

Council's finance team have aided in modelling the potential impact to the adopted 2023/24 Long-Term Financial Plan (LTFP) of Council's Domestic Waste Management Fund (DWM) to model potential impacts associated with increased waste service costs the Receival, Processing and Disposal for Municipal Waste and Resource Streams.

External Communication and Consultation

External Communication and Consolation has been restricted to the Project Working Group, Project Control Group, legal advisors, probity advisors and subject matter experts.

SUSTAINABILITY ASSESSMENT

Environment

There are positive environmental impacts in relation to this report through the increased diversion of waste from landfill. The option for Bulky clean up waste to be processed for resource recovery at a facility in Cecil Hills operated by Brandown Pty Ltd will have a positive 5% improvement on Councils waste diversion performance.

<u>Social</u>

There are no social impacts raised directly in relation to this report.

Broader Economic Implications

There are no broader economic implications in relation to this report.

<u>Culture</u>

There are no cultural issues raised directly in relation to this report.

Governance

The Probity Advisor (OCM) appointed to oversee the original tender process continued to provide probity advice and was involved in the various stages of the negotiations including correspondence, meetings and final contract discussions.

COUNCIL BUDGET IMPLICATIONS

The negotiated contract rates for the Receival, Processing and Disposal Services for Municipal Waste and Resource Streams are significantly higher than the current contract arrangements and are reflective of the current market rates and uncertainty in the waste facility/ resource recovery commodity markets.

Mixed Waste (MSW)	66%
Bulky/ Clean up waste	6%
Recycling	137%
Organics	235%

The following are the respective increases for each waste stream:

The adopted 2023/24 LTFP has been updated to reforecast the financial capacity of the DWMC to incur the increased disposal and processing costs, in addition to future potential increases as a result of maintaining the bulky waste collection service, increase costs for a new collection contract in June 2026 and the introduction of FOGO in 2029. The reforecast LTFP was developed to minimise the impact on customers by funding the increased costs utilising existing cash reserves and applying a consistent percentage increase in the DWMC in each year of the LTFP.

A 4.00% increase on top of the adopted LTFP indexation for revenue has been applied to each year of the LTFP.

The DWM cash reserve balance is projected to stay above \$2.5 million for the term of the LTFP which is considered adequate.

Reforecast LTFP Assumptions

Funding of cost increases

The updated LTFP has been developed to minimise the short-term impact on customers by funding the initial increased costs by utilising existing DWM cash reserves and applying a consistent increase in the DWMC for each year of the LTFP. A 4.00% increase on top of the adopted indexation has been applied to each year of the LTFP which is adequate to not diminish the DWM reserve below acceptable levels. The indexation will be reviewed annually as apart of Council developing its Operational Plan and Budget.

The Domestic Waste Management reserve balance as at 30 June 2023 as per the draft Financial Statements is \$8.076million.

This existing DWM reserve can be utilised to assist in covering the increased costs of waste disposal and collection rather than having a spike in the DWMC for ratepayers in the 2024/25 financial year. This will mean that the DWM slowly diminish from 2024/25 to 2030/31 to a projected reserve balance of \$2.6 million.

From 2031/32 the DWM Fund will be replenished with a projected balance of \$3.4 million at the end of 2032/33.

Operating Result

The Income Statement in shown in Figure 1.

After considering the increased waste disposal/collection costs and increase in revenue, the operating performance of the DWM reports deficits for several years to minimise the financial impact to customers. The operating result returns to sustained surpluses from 2031/32. The operating deficits will be offset by the DWM reserve.

Cash Forecast

The net reserve movements for each year of the LTFP are shown in **Figure 2**.

The graph below illustrates the projected cash balances of the DWM for the next 10 years.



Other cost related impacts

The increase in processing/ disposal costs will be passed through directly to the Resource Recovery Centre users through increases to the 2024/25 fees and charges on a full cost recovery basis as per the Category 1 fee classification.

NSW Environmental Protection Agency Waste Levy

The Waste Levy applies in the regulated area of NSW which comprises the Sydney metropolitan area, the Illawarra and Hunter regions, the central and north coast local government areas to the Queensland border as well as the Blue Mountains, Wingecarribee and Wollondilly local government areas.

The Waste Levy is paid on:

- waste received from the regulated area, if the landfill is located outside the regulated area
- all waste received at an EPA-licensed landfill, if the landfill is located in the regulated area

The application of the Waste Levy to waste generated within the Shire increases costs by \$163.20 per tonne.

RELATED COUNCIL POLICY

The proposed contract arrangement supports Councils' Waste and Resource Recovery Strategy (currently on public exhibition) key direction in improving Resource Recovery from waste streams.

CONCLUSION

A joint tender and negotiation process has been completed to meet the waste and resource receival, processing and disposal needs of the Wingecarribee community. Based on the outcomes of this process, as detailed in the Negotiation Report, the two recommended contracts with Veolia Recycling and Recovery Pty Ltd and Cleanaway Pty Ltd present the best value to Council for the services over the next 5 years. As such it is recommended that Council enters into (and the General Manager be authorised to execute) these two contracts for the receival, processing and disposal of municipal waste and resource streams.

6.2 Wingecarribee Women Writers - The Charlotte Project

PURPOSE

The purpose of this report is to seek approval for The Charlotte Project, to be delivered by the Wingecarribee Womens Writers, in line with Councils Public Memorials Policy and Guidelines.

OFFICER'S RECOMMENDATION

THAT:

- 1. Council approve The Charlotte Project, by Wingecarribee Womens Writers, under the Public Memorial Policy and Guidelines.
- 2. Upon consideration of the submissions received during the public consultation of 25 to 31 October 2023 and the existing letters of support, that further consultation through a period of public exhibition is not required.

REPORT

The Wingecarribee Womens Writers have submitted a proposal to Council for the installation of a monument within Berrima Marketplace Park to celebrate the life and contribution of local author Charlotte Atkinson. Landscape drawings of the proposed monument are provided in Attachment 1.

Charlotte Atkinson and her daughter Louisa are two of the most significant women in the history of Australian literature, however there is no monument recognising their achievements and they lie in unmarked graves. It is the desire of the newly formed Wingecarribee Women Writers group to ensure that these two women are accorded their place in the history of the Southern Highlands and the country.

Although the proposal will be subject to a development approval pathway, like all works, the proposed monument also requires a separate approval from Council under Council's Public Memorial Policy and Guidelines.

The purpose of this report is to seek this Public Memorial Policy and Guidelines approval for the proposed monument. The development approval considerations of the proposed works, as described below, will be managed through existing delegation as per standard process.

Public Memorial Policy and Guidelines

Council's Public Memorial Policy and Guidelines provide an extensive list of requirements for proposed monuments within parks and reserves, to which the Wingecarribee Womens Writers group have provided a detailed response to each – Attachment 2.

Review and Recommendation

Upon review of the application and supporting documents provided by Wingecarribee Womens Writers, it has been determined that the Charlotte Project is in alignment with the Public Memorials Policy and Guidelines.

Charlotte Atkinson, and the Atkinson family in general, have sufficient connection to the proposed location. The Atkinsons resided at 'Oldbury' and their property's boundary stretched to the township of Berrima - which was the commercial centre for the Atkinsons at that time and developed rapidly as the major transport route south. The proximity to the children's playground in the park also adds to the symmetry of the story with the installation of Charlotte reading to her children. The location of the installation on the western end of the park reads to the connection with the Atkinson family who owned the corner block of Jellore/Bryan Street. Although the installation is of Charlotte Atkinson, it can also be understood as to represent women living in the heritage properties overlooking Berrima Market Place as she is a reflection of the time period.

The proposal does not conflict with the Conservation Management Strategy (CMS) of the reserve. The stated purpose of the CMS is to provide ongoing management guidelines for the vegetation within Market Place Park, as opposed to being a conservation management plan for the park as a whole. The proposal does not impact the existing vegetation of the site and, as per the recommendation of the CMS, does not include the introduction of any more plaques.

The proposed location of the monument is within the grassed area noted within the Berrima Market Place Masterplan to be retained and enhanced for light and passive recreation opportunities. The Charlotte Project aligns with the objectives of this area through enhancing the picnicking and social gathering activities of the space.

With the Arts and Culture Advisory Committee no longer being in existence, endorsement of the artistic intent and merit of the project has instead been provided by Manager Community Life and Libraries and the Arts and Cultural Officer.

Community Consultation

Letters of support for the project have been provided from the Berrima Residents Association, Berrima District Historical and Family Society and Australian Garden History Society - Southern Highlands Branch.

In addition, community consultation has been conducted on the proposal from 25 October 2023 to 31 October 2023. The consultation was conducted through the Wingecarribee website and was promoted through letter box drops to adjacent residents and included within Council's weekly engagement newsletter.

The results of this consultation are provided in Attachment 3, with the following table being a summary:

Upon consideration of the above, it is concluded that The Charlotte Project holds considerable community support and therefore it is recommended that a further period of public exhibition is not required.

Development Approval Pathway

Council's Approval To Carry Out Work on Council Property (ATCOW) process enables community groups and organisations to complete works on Council land and buildings.

The Transport & Infrastructure State Environmental Planning Policy designates many of these types of projects as 'Development Permitted without Consent' and so are to be considered through a Part 5 assessment, as opposed to a Part 4 assessment under the EP&A Act 1979.

A Part 4 assessment is in essence the Development Application (DA) process which is governed by Development Control Plans (DCP) and Local Environmental Plans (LEP). The Part 5 assessment is instead completed through a Review of Environmental Factors (REF) assessment.

Therefore, for works that the Transport & Infrastructure SEPP deem as 'Development Permitted without Consent' no DA is required nor does the DCP or LEP apply.

The development approval pathway for The Charlotte Project is therefore through Clause 2.73 of the Transport and Infrastructure SEPP:

- 2.73 Development permitted without consent
 - (3) Any of the following development may be carried out by or on behalf of a public authority without consent on land owned or controlled by the public authority—
 - (a) development for any of the following purposes-
 - (v) landscaping, including landscape structures or features (such as art work) and irrigation systems,

The Charlotte Project, for the development approval pathway, will therefore be assessed through an ATCOW application, supported by an REF and Statement of Heritage Impact (SOHI) given the local heritage significance of Berrima Market Place Park. The ATCOW will be reviewed, and a determination made, in accordance with existing delegations of Council officers.

COMMUNICATION AND CONSULTATION

Community Engagement

Letters of support for the project have been provided from the Berrima Residents Association, Berrima District Historical and Family Society and Australian Garden History Society - Southern Highlands Branch.

In addition, community consultation has been conducted on the proposal from 24 October 2023 to 31 October 2023. The consultation was conducted through the Your Say Wingecarribee website and was promoted through letter box drops to adjacent residents, social media and the Berrima Residents Association.

SUSTAINABILITY ASSESSMENT

Environment

The purpose of this report is to seek Council's endorsement that the monument aligns with the requirements of the Public Memorial Policy and Guidelines – of which there are no environmental considerations or constraints noted. The environmental and heritage considerations are part of the development approval pathway, of which is not the purpose of this report.

<u>Social</u>

It is estimated that across Australia, less than four percent of public statues are of women. There are more statues of farmyard animals than there are of women. The Charlotte Project will help correct this trend and will support the fundamentally change this statistic and will become the first monument to recognise the important contribution of a pioneering woman to the life and community of the Southern Highlands.

Broader Economic Implications

The Charlotte Project will further enhance the appeal and tourism appeal of Berrima, and so will only help to further support the local businesses within the village.

<u>Culture</u>

There are no cultural issues in relation to this report.

Governance

It is deemed that the Charlotte Project aligns with the requirements of the Public Memorials Policy and Guidelines.

COUNCIL BUDGET IMPLICATIONS

There are no budgetary implications of this proposal. Construction and installation of the Charlotte Project is to be fully funded by the Wingecarribee Womens Writers group. And as per the Public Memorials Guidelines, should the memorial be damaged, lost or vandalised the subsequent repair and replacement costs will remain the responsibility of the applicant.





RE: Proposed Monument to Honour Charlotte Atkinson – The Market Place, Berrima

I am delighted to write to Council on behalf of the Wingecarribee Women Writers (WWW) with this very exciting community project and to seek Council's endorsement for the project to proceed. This project is proposed under the Council's Public Memorials Policy and Guidelines as approved by Council on 28 October 2020.

Before I address how the project is consistent with Council's Public Memorials Policy and Guidelines, I would like to provide some background and context to demonstrate the project's relevance to the Shire.

Charlotte Atkinson and her daughter Louisa are two of the most significant women in the history of Australian literature and yet there is no monument recognising their achievements and they lie in unmarked graves. The newly formed Wingecarribee Women Writers (WWW) group wants to ensure these two remarkable women are accorded their rightful place in the history of the Southern Highlands and the country.

We seek Council approval for a bronze statue of Charlotte Atkinson and her four children, including Louisa, to be placed in The Market Place Berrima near the new children's playground. It will be a low statue and Charlotte will be depicted sitting on the ground with her four children around her reading a book or sketching. The statue will most likely be bordered by a small sandstone edge.

The Writers group is raising money to fund plaques for Charlotte and Louisa's graves in the All-Saints Graveyard, Sutton Forest and to erect the sculpture which we envisage as a centrepiece in The Market Place Berrima.

Further information detailing the significant achievements of Charlotte Atkinson and her daughter Louisa as well as their rich historical association with the Southern Highlands is provided on page 6 of this document.

Public Memorials Policy and Guideline

Under Council's adopted Public Memorials Policy and Guideline, a section is dedicated to Monuments, Statues and other Memorials. The following seeks to satisfy each of the guideline requirements:

Any new large memorial must be demonstrated to be of lasting value to the community for social, cultural, historical, educational or aesthetic reasons, and must add to the existing community amenity of the proposed location within the context of the current and future use of the area. Monuments, statues and other memorials will only be considered for a person who is deceased.

Response

Charlotte Atkinson died in 1867 and her daughter Louisa, just five years later in 1872. The proposed bronze sculpture will depict the author of Australia's first children's book engaging her own children in reading and sketching. The statue and its placement near the Children's Playground and not far from the Berrima District Museum and Story Centre will complement the social, cultural, educational, and historic nature of the area. It's envisaged that children will be able to engage closely with the monument. In addition, the design and quality of the statue will become one of the focal points of the park and surrounding space. It will draw both passing visitors and locals and encourage them to broaden their knowledge about the history of the area and the pivotal role played by pioneering women.

Subjects for a large memorial will only be considered appropriate if they meet one or more of the following criteria: the subject is or was an individual or association that has contributed significantly to the cultural or social aspects of the development of the region, including; more than 20 years dedicated to the development of the region; or more than 20 years not-for-profit work on a community or social cause, such as sports, education, arts, culture, or providing assistance to the vulnerable; or the large memorial commemorates a significant anniversary of an event unique to the region's history and development.

Response

The Atkinson family had a long association with the Berrima area and the Southern Highlands. James Atkinson built the house known as Oldbury Farm as his wedding gift to Charlotte in 1828. It still stands today on Oldbury Road between Sutton Forest and Berrima and is heritage listed as one of the oldest existing examples of a Colonial Georgian country house on the Australian mainland. Charlotte's contribution to the local community was immense. She oversaw the accommodation and care of convicts and other workers on the huge property. She tended the sick among the local indigenous population and taught both her own and local children. The Atkinsons also sponsored the family members of some convicts to join them in the colony. Both Charlotte and her daughter spent hours exploring the unique flora and fauna and documenting their botanical discoveries through sketches and drawings. These became integral contributions to the building of knowledge about the Colony's plants and animals.

In addition, the subject of the memorial must have a strong connection to the proposed site of the memorial. Large memorials for political or religious figures will only be considered if that person has also contributed to the community outside of their political or religious life, in accordance with the criteria outlined above.

Response

As outlined above, the Atkinsons resided at 'Oldbury' and their property's boundary stretched as far as the area which became the town of Berrima in 1831. After the death of her husband, Charlotte herself would ride out with the farm manager to inspect the far reaches of the property and it was at the river near Berrima that she and her farm manager were attacked by the infamous bushranger and serial killer, John Lynch. Charlotte and her children lived in the area for many years and their connection to the history of Berrima and surrounds is indisputable.

Approval will only be granted for a new large memorial if it is consistent with Council's master plan or strategic development framework for the site. Any proposal for a large memorial that may be considered to be an artistic work must be endorsed by Council's Arts and Culture Advisory Committee.

Response

We acknowledge that The Market Place Berrima is a heritage listed site under Wingecarribee LEP 2010. We also understand Council several years ago adopted a masterplan for The Market Place. We believe the placing of a monument to Charlotte Atkinson in the park is entirely consistent with the Park's Masterplan and will enhance the heritage significance of the park. Furthermore, it will help place Wingecarribee Council at the forefront of a global movement of commemorative justice for women - to give women their rightful recognition in terms of monuments and statues. It will become the first monument to recognise the important contribution of a pioneering woman to the life and community of the Southern Highlands.

Any request for a large memorial should include evidence of community consultation on the memorial's purpose, location and design, in the form of at least three letters of support from relevant or affected interest groups and/or organisations. Council reserves the right to undertake further consultation or direct the applicant to undertake further consultation if it is considered necessary.

Response

WWW has engaged with local community groups including the Berrima District Historical and Family History Society, Berrima Residents Association and surrounding property owners who have all supported the project and copies of their letters of support are attached.

Applicants for a large memorial must meet all costs associated with the design, manufacture and installation of the memorial. Council will oversee the installation of any large memorial and may require specialist contractors to advise on and/or install the memorial. Should the memorial be damaged, lost or vandalised, repair and replacement costs would remain the responsibility of the applicant.

Response

WWW has already embarked on an extensive fundraising drive. We plan on holding a fundraising cocktail party as part of the Southern Highlands Writers Festival on 15 October 2022, as part of the

10-year anniversary of the festival and the 10-year anniversary of the Stella Prize for Women's Literature. It's anticipated this event will raise significant funds for the project.

We expect to have the funds to order the memorial plaques for the graveyard by October, with installation by early December to coincide with the 181st anniversary of Charlotte's book being published. The cocktail party will be the official launch of the fundraising efforts and for this reason we are hopeful of Council approval prior to this launch date. We are very confident of receiving the necessary funds through donations for the design, casting and installation of the monument.

No new memorial will be considered which commemorates a person, event or occasion that is already the subject of a memorial in the Wingecarribee Shire unless there are exceptional circumstances, such as the commemoration of people or events with immense national or international significance.

Response

As detailed above, there is no monument in existence dedicated to Charlotte and Louisa Atkinson. In fact, there are no monuments to actual women in the Wingecarribbee Shire at all. It is noted that two monuments exist in the Shire dedicated to one male resident and one fictional character associated with the Southern Highlands. The monuments in Glebe Park Bowral are Sir Donald Bradman and the fictional character, Mary Poppins. Berrima has no existing person related monument.

To provide a context of the proposed location and scale of the monument, the following photo is provided which shows a figure of a person sitting on the grass.



It is our great hope that Council accepts the detailed justifications for the installation of the monument and gives approval for the project. As mentioned previously, we would like to formally announce the project at the upcoming Writers Festival Event on 15 October 2022 so we are hoping for Council approval prior to this date.

Charlotte Waring Atkinson - Australia's first children's author

According to an article in the Sydney Morning Herald, Charlotte Waring Atkinson (1796-1867) was "one of the most accomplished women of her era." She was a fiercely independent, well-educated woman; an early feminist and a loving mother with progressive views on girls' education who brought her daughters up to be some of the finest scholars, artists and writers in the colony, a naturalist, ethnographer, and the first Australian children's author.

She emigrated to Australia in 1826 after being employed as a governess by Maria and Hannibal Macarthur. On the voyage she met agriculturist James Atkinson and they were married a year later and settled at 'Oldbury' in Sutton Forest which is the earliest surviving Colonial Building in Wingecarribee Shire. Charlotte was a pioneer in the fight for women's legal rights, defending a landmark case in the Supreme Court of NSW to retain custody of her own children, after suffering domestic violence at the hands of her second husband. Charlotte also survived a brutal attack by bushranger and serial murderer John Lynch.

Caroline Louisa Atkinson - our first female Australian born journalist and novelist

Educated at home by her mother Charlotte, Louisa (1834-1872) was a talented artist, botanist, zoologist, environmentalist, and writer. She was the first Australian born female journalist and female novelist. Louisa is notable for her contribution to the knowledge of natural history and botany, collecting and sketching numerous specimens, several previously unknown, and sending plants to eminent botanists such as William Woolls and Ferdinand Mueller. There are several ferns named after her.

Historical Relevance

The Atkinson family were pioneer farmers in the Southern Highlands, with James Atkinson, receiving one of the earliest land grants in the district at Oldbury, near Sutton Forest, which he began farming in about 1822. Charlotte moved to Oldbury after their marriage in 1827. Both Charlotte and Louisa wrote extensively about First Nation people, and their unique culture. They were early feminists, with Charlotte fighting for her right to raise her own children and exert her financial independence, in the landmark legal case which benefited women throughout the British Empire. Louisa frequently wrote about independent, working women and was the subject of colonial gossip for wearing trousers on her botanical jaunts. Charlotte and Louisa's unmarked grave is at All Saints, Sutton Forest.

Literary Importance

Charlotte Waring Atkinson was the first Australian children's author, credited with writing several books. In 1841, Charlotte wrote *A Mother's Offering to Her Children by a Lady Long Resident in NSW*. It was the first children's book published in Australia, and the first to feature Australian children, landscapes, history, flora and fauna, and the lives of its First Nation people. The book gives a rare insight into colonial domestic life, and the unique role played by mothers in educating their children. *A Mother's Offering* is considered so important that a first edition copy recently sold for \$70,000.

Louisa Atkinson was the first female Australian-born novelist, journalist and botanist. Her early articles and drawings were published at the age of 19, in *The Illustrated Sydney News*, and she continued to write a long running series of articles A Voice from the Country, for the Sydney Morning Herald, as well

as articles for *the Sydney Mail* and *The Horticultural Magazine*. Many of these were about the importance of environmental protection and several focused on Indigenous Australian culture and artefacts. Louisa's first novel, *Gertrude the Emigrant*, was published in 1857 when she was aged 23. This was followed by several novels including *Cowanda*, and *Debatable Ground*.

I am writing in support of the Wingecarribee Women Writers project to erect a bronze statue in Berrima to acknowledge the life and work of Charlotte Atkinson and her daughter Louisa, two women who made a significant contribution to the early history of our area and to the literary world of their time.

Charlotte settled with her husband James Atkinson at Oldbury, Sutton Forest in 1826 and after his death in 1834 was vitally involved in the running of the property. She was well educated and a talented artist and is acknowledged as the first Australian children's author with the publication of *A Mother's Offering to her Children* in 1841. Charlotte was an independent and brave women who stood against convention to retain custody of her children after her husband died.

Her youngest child, Louisa, inherited her mother's artistic and literary talents, and is much celebrated as a botanist, artist, novelist and journalist, with several books having been written about her. The achievements of Charlotte and Louisa have long been recognised by local historians and both women were included when the Berrima District Historical Society honoured significant women of the Southern Highlands in a Bicentennial project in 1988. As a historian, my own research into the Atkinson family over many years has given me a deep knowledge of the part they played in this early period, including their interest in and understanding of the local Indigenous people with whom they had excellent relations.

Charlotte and Louisa Atkinson are both buried at All Saints Cemetery, Sutton Forest although the graves are currently unmarked. Wingecarribee Women Writers, as well as raising funds for the statue, aim to erect a memorial plaque in the cemetery.

I believe this to be not only a worthy project but the statue and interpretive panel will add to the experience of visitors to Berrima and their knowledge of women's history in early New South Wales. I commend the project and urge Wingecarribee Shire Council to support it.

Support for Caroline Atkinson Statue in the Berrima Children's Park

Dear Lynn,

Formed in 1980, the Australian Garden History Society brings together people from diverse backgrounds united by an appreciation of and concern for our parks, gardens and cultural landscapes as part of Australia's heritage. The Society promotes knowledge of historic gardens, significant landscapes and research into their history. It aims to examine gardens and gardening in their widest social, historic, literary, artistic and scientific context.

As the Chair of the AGHS-Southern Highlands Branch I would like to support the efforts of the Wingecarribee Women Writers group to erect a sculpture featuring Charlotte Atkinson and her daughter Louisa in the Berrima Children's Park as they embody historical accomplishment not shared by many early settlers.

Charlotte Waring Atkinson was an educated woman who arrived from England in the early 1800s. She helped manage Oldbury Farm, after the death of her husband, James Atkinson, in a very remote area at the time. Oldbury has been restored to its former glory and shows us all how challenging an environment this must have been 200 years ago. She was an early feminist and educated her daughters to be some of the finest scholars, artists and writers in the colony. Charlotte herself was a pioneer in the fight for women's legal rights and was Australia's first children's author.

Her daughter Louisa Atkinson under her mother's tutelage became a talented artist, botanist, zoologist, environmentalist and writer. Louisa was the first Australian born female journalist and novelist. While she was well known for her fiction during her lifetime, her long-term significance rests on her botanical work. She collected specimens extensively for Rev. Dr. William Woolls, a well-known teacher and amateur botanist, and Ferdinand von Mueller. Mueller's work was aided by many amateur naturalists in Australia, but Louisa's contribution was noted "for the quality of its information, its scholarly commitment, its enthusiasm and persistence over time, its geographical range, its local depth, its robustness and liveliness of descriptive record, its sense of primary exploration, its sheer inventiveness".

These two women are regarded by many scholars as two of the most influential women of their era and warrant recognition in an area so closely related to their origins in Australia. Such role models may have the ability to influence young lives in our community today. So locating a statue of these women in the Berrima Children's Park will give them the recognition they deserve for having such an impact on not only the Wingecarribee Shire but also Australia wide.

Re: Charlotte Project.

I write to object to the proposed monument on a number of grounds and to question the process which has been undertaken to date.

1 – Inappropriateness

There is currently no recognition of First Nations People in the area and specifically in Berrima, despite 60,000 plus years of unbroken connection to the land.

That Wingecarribee Shire Council is proposing another commemoration of colonial history with its inherent privilege, ahead of acknowledging the continuous cultural heritage of the first inhabitants of this land including their tens of thousands of years of storytelling traditions, is frankly deeply concerning in 2023.

Have the region's First Nations People been consulted as to this statute and its appropriateness or otherwise?

Further, can Council please detail how it has undertaken considerations of the impact of the perpetuation of white colonial privilege through such projects on publicly owned council property, what policy framework underpins this approach and what it is doing to equal the imbalance when it comes to recognition of First Nations People in Berrima and the Shire?

I refer Council to the City of Sydney which is undertaking a significant review of statuary erected on the basis of celebration of colonial privilege, to determine its suitability in respect of First Nation's history.

2 – Impact on local heritage item and state heritage items

I have written previously to Council about the profound impact that ad hoc proposals such as this planned statue – as well as other overdevelopment and inappropriate development – is having on the heritage fabric of Market Place.

Market Place Berrima, including the immediate surrounding street curtilages with eleven (11) NSW State Heritage listed items facing the park, is one of the most significant heritage



precincts in NSW. It is a largely undeveloped centre of a regional town which reflects early colonial settlement which is rare at a state and national level.

Market Place is first and foremost, a significant Georgian design feature of perhaps the last remaining, intact Georgian village on the Australian mainland. It is not a park or recreation ground in the traditional sense – rather the town centre of the village as it was designed in 1831 and which has survived to today mostly intact.

Critically, Market Place's heritage significance is intrinsically connected to the heritage fabric of the surrounding streetscape along its four street boundaries, Jellore, Bryan and Argyle Streets as well as Market Place. Of particular note is the interconnectedness of Market Place with the unformed street curtilages of Jellore, Bryan and Argyle Streets with their unsealed road edges, lack of formed guttering and with an overall sensibility of country lanes.

This is enhanced by the no less than 11 NSW State Heritage Listed items which surround Market Place on three streets and all of which face into Market Place and at various points, can be viewed across it. These eleven heritage items account for <u>68.75% or more than two</u> thirds of all the NSW State Heritage listed items in Berrima. The inventory of NSW State Heritage listed items can be seen in the extract from NSW Heritage's <u>online database and</u> <u>search</u> function.

Statuary in Market Place was previously rejected by the community and Council during a recent master planning process undertaken ahead of the expansion of the children's play area. This process saw draft plans shared with the community and feedback sought on them, the outcome of which was a resounding 'No' to the insertion of statuary in Market Place. A position I understand was also supported at the time by the Berrima Residents Association.

Much of the objection to the placement of statuary at that time was based on the impact that it would have on Market Place as a heritage item, as well as being completely contrary to the Berrima Village DCP which states clearly:

(a) New recreation and community facilities shall only be permitted where they are consistent with a Conservation Management Plan that has been endorsed by the NSW Heritage Branch.

This proposal is not just for a statue, but I understand a large sandstone plinth as well as at least 5 other sandstone plinths surrounding the statue with additional landscaping.

This will profoundly impact the simple Georgian design of Market Place and irreversibly impact the location's heritage fabric.

Market Place has a long tradition – starting with the 1890 planting of the Henry Parkes Oak and the subsequent 1897 planting of the trees to mark the Jubilee of Queen Victoria, as well as many others - of commemorating in a subdued and dignified manner events and people through planting of trees with appropriately small plaques.



This has been an approach which has respected the heritage of Market Place as well as its preserving its Georgian design and integrity.

The current proposal for a statue is entirely contrary to this approach that has worked for the best part of two centuries, and if it proceeded it would establish a regrettable precedent in this very important part of Berrima.

3 - Lack of proper process

The Council has rushed this proposal without proper community consultation, completely at odds with the master planning of Market Place only a few years ago which ironically saw proposals for similar statuary rejected by both Council and the Community.

Residents have been provided with less than 5 days to respond to a letter which is lacking in any detail, imagery of the proposed statute and additional landscaping including multiple sandstone plinths, or a map showing the exact location.

Nor has any heritage impact statement been provided to residents to review.

Why has this proposal been pushed through with unseemly haste, in a process which is completely at odds with that required under the Local Environment Plan and its mandatory provisions?

As Market Place is an item of local heritage, Wingecarribee Shire Councils is required, legislatively, to follow the provisions of the LEP which are mandatory and not discretionary.

Clause 5.10, paragraph 2 (a) of the of the LEP states that development consent is required for:

(a) demolishing or moving any of the following or altering the exterior of any of the following (including, in the case of a building, making changes to its detail, fabric, finish or appearance)

Given there is not a duly democratically elected Council in place in Wingecarribee Shire, the only appropriate decision is for Council to withdraw this application and properly lodge a development application with all attendant opportunities for proper community consultation to take place, as well as liaison with state agencies including NSW Heritage.

I reiterate my complete opposition to this proposal.

Regarding 'Notification of Application for Public Monument' - 'Charlotte Project'

Firstly I'd like to express my disappointment at Council's insincere and inadequate attempt at community consultation on this significant development proposal.

Council's notification letter was dated October 25 and was received October 26 with responses to be returned by October 31. This only gives residents three working days and a total of five days in which to respond. Best practice with any genuine community consultation is two full weeks minimum. It is unclear why Council deliberately chose such a short timeline and why it is rushing this proposal given it is not observing a proper development application process.

Council's notification letter is deficient in a number of details including:

-The size of the sandstone block plinth on which the statue will be placed. In fact no imagery, diagrams or plans of the proposed statue and landscaping has been provided.

-The size and nature of any additional landscaping (including additional sandstone blocks which I understand to be five (5) in number).

-The specific location of the proposed statue's location in Market Place - no map has been provided to residents to review.

-The website linked on the notification (<u>https://www.wwomen_writers.org/</u>) also fails to provide any of these crucial details.

-There is no reference to any advice Council may have sought from its own Heritage advisor on the proposal or from NSW Heritage, given that all of Berrima is a heritage conservation area and Market Place itself is a local heritage item surrounded by 11 NSW State Heritage listed items. Market Place provides a crucial role in maintaining heritage view corridors across the park to and from these important buildings.

-There is no documentation provided regarding what relevance the subject of the statue has specifically with Berrima village.

I expect these details should have been provided so that residents may provide responses once we have been adequately informed.

Even in this state of information deficit I have a number of serious concerns regarding the proposed statue and indeed any other major development in Berrima's Market Place.

Berrima Market Place is one the oldest and most significant Heritage items in the district and indeed the country as it forms the central focus of the highest concentration of NSW State Heritage items in Berrima and indeed Wingecarribee Shire.

Berrima village is significant as the only intact Georgian village surviving on mainland Australia.

The heritage values of these buildings lies not just in their own built material but in the landscape and environment in which they sit. Market Place is crucial to this heritage significance as it still retains its unadorned, simple rural character with unmade edges, rough grass and towering trees.

The addition of a bronze statue is totally out of step with this unadorned rural character and is an insult to the almost two hundred years of history during which the erection of any statues in Market Place have been resisted.

Given the impact this statue will undoubtedly have on the heritage values of the many surrounding NSW state heritage listed buildings it would be unconscionable for Council to proceed without adequate consultation from the community and without seeking detailed feedback from NSW State Heritage which would be made available in a proper development process.

Council is in the process of proposing to add hundreds of local properties to the local heritage register. What is the point of any of these listings if council ignores its own DCP and LEP for heritage listed Berrima village by allowing a new development within Market Place without a proper development application process?

As there is a current nomination for Berrima village as a whole to be included on the NSW State Heritage register, as well as a separate nomination for Berima's Market Place and street curtilages along Jellore, Bryan & Argyle Streets as well as Market Place it would be inappropriate for Council to approve such a significant development in the most important heritage item within the village.

I also have serious concerns regarding the appropriateness of the subject of the proposed statue. What message is Wingecarribee sending by erecting a statue to white colonial privilege when there is a profound lack of any monument or interpretive walks in Berrima and the wider district to tell the history of our Gundungurra and other First Nations People. The erection of a statue celebrating a privileged white colonialist as one of our first storytellers blatantly ignores our true history of 60000 plus years of a culture built on storytelling. It is disappointing that in 2023 we are perpetuating commemoration of one aspect of our history at the expense of another. It is a sad fact that much of our colonial history was built on the trauma of First Nations People yet this has yet to be recognised in Wingecarribee Shire.

Has Council considered any other locations for the statue? If the concern is that the subject of the statue lies in an unmarked grave then surely that gravesite would be a more appropriate location for any statue as it was the subjects chosen resting place in the village in which she actually lived.

Finally, I'd like to point out that Wingecarribee council is currently under administration and as residents we have no democratically elected representatives to make decisions that affect us all and in this case, how we as a community and our shared history are authentically and truthfully represented.

It would be most inappropriate for a council in this current state to authorise such a significant change to a heritage item without the scrutiny and fairness that an elected council can provide.
