Note 2 Chapter 2 of the Criminal Code applies to all offences against the Statutory Declarations Act 1959 — see section 5A of the Statutory Declarations Act 1959.

**A statutory declaration under the Statutory Declarations Act 1959 may be made before—**

1. a person who is currently licensed or registered under a law to practise in one of the following occupations:

Dentist	Optometrist	Trade marks attorney
Legal practitioner	Patent attorney	Veterinary surgeon
Medical practitioner	Pharmacist	Physiotherapist
2. a person who is enrolled on the roll of the Supreme Court of a State or Territory, or the High Court of Australia, as a legal practitioner (however described); or
3. a person who is in the following list:
  - ☞ Agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public
  - ☞ Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the Consular Fees Act 1955) ☞ Bailiff
  - ☞ Bank officer with 5 or more continuous years of service
  - ☞ Building society officer with 5 or more years of continuous service
  - ☞ Chief executive officer of a Commonwealth court
  - ☞ Clerk of a court
  - ☞ Commissioner for Affidavits
  - ☞ Commissioner for Declarations
  - ☞ Credit union officer with 5 or more years of continuous service ☞ Employee of the Australian Trade Commission who is:
