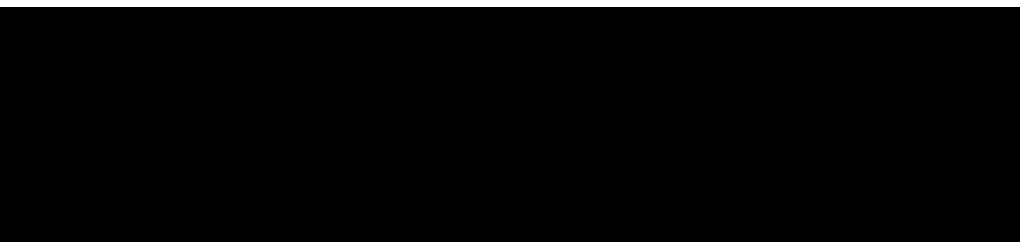
GENERALLY:

- 1) Regarding the application to speak, sent PM Sunday 18th:
I made reference to a 3 minute, non-technical video by a Dr Bill Putman of NASA that WSC could download or I supply on the night via USB thumb drive.

It would be best if I could send to you the AV file via a dropbox or similar download link and you have it ready to play in your system. WHY?

Whilst not altering the intent of the video, I edited out the modelling segments of no relevance to the meeting and reduced the file time to 2minutes of relevance.

- 2) Putman's modelling used actual historical data to create a visualization of the CO2 concentrations in both hemispheres, and the variances in output depending on season that is causing Global Greening due to CO2.
- 3) My intention is to demonstrate that persistent, official orchestrated lies have led to a misinformed public, and the waste of funds such that all Council is doing is a "Don Quixote".
- 4) Council has an obligation to ratepayers to be properly informed and consider facts and perspective – NOT merely behave as a bureaucratic Lemming.

My name is Peter Cunningham, [REDACTED] and am among other things an experienced Civil Engineer.

OPENING COMMENT

Crucial to my presentation to warn council that the current Environmental "Strategy" is based on false information.

To correct that information required me to present a very short AV from NASA regarding actual 2023 global data that used a super-computer to model a year's movements of CO2 in both hemispheres.

I have been thrice stopped from presenting factual information by Coordinators Governance.

- The first was cited Copyright as the justification – that I immediately proved was invalid.
- Then "Council does not broadcast third party material" – so I chose instead to provide a short 1minute video file containing two URL's at NASA for people to check in their own time.
- That I sent via email, but it too was refused – approved at the 11th hour today.

The purpose of me bothering with this presentation is:

- 1) To demonstrate that persistent, official orchestrated lies have led to a misinformed and alarmed public - which includes people at Council. It is the basis of this "Environmental Strategy" I now partly challenge.
- 2) To demonstrate that Council is doing a "Don Quixote".
Because said misinformation is grossly in error, unless corrected, the result can only be the further waste of ratepayer funds – for NIL gain.
- 3) To show that the basis of Council's aims is wrong:
"We need to reduce greenhouse gas emissions to minimise the extent of climate change and also adjust the way we do things to adapt to the already changing climate."

Regarding the first part of Council's aims:

The Official Lie is that Australia can manipulate climate change by reducing emissions of a trace gas. That top-down political decree has never been substantiated – hence the continual predictive modelling that is constantly well removed from observed data.

The NASA research I hoped to present confirms the irrelevance of Australia in emissions -except bushfires. That is why it is of such importance to derail the Environmental Strategy until it is corrected and restructured.

Regarding the second part:

Adapting to constantly changing climate has been a historical fact for hundreds of thousands of years . This is not new - we will adapt as there is no choice so some of what Council chooses to do is sensible.

Absurdly - all is immediately offset by forced increases in local population!

SO WHAT IS THE TRUTH?

The NASA modelling by Dr Bill Putman of 2023 data shows that Australia's actual Greenhouse emissions are so utterly insignificant that the NASA CO2 data does not even register to be modelled.

This is a STARK contrast to the official Green narrative that Council is enthusiastically pursuing.

That is why I wanted to introduce facts and perspective.

WHO IS Dr BILL PUTMAN?

Dr. William Putman is a research meteorologist within the Global Modeling and Assimilation Office at NASA/GSFC.

He is responsible for development and integration of advanced numerical methods for atmospheric dynamics and physics parameterizations within the NASA earth system models including the GEOS modeling and assimilation system.

A key element of his work is algorithm optimization for existing and emerging high end computing platforms.

He received his PhD in meteorology from the Florida State University in 2007 for the implementation of the finite-volume dynamical core on the cubed-sphere geometry.

The extension of the finite-volume numerics to the cubed-sphere geometry poises the finite-volume dynamical core for application on emerging peta-scale systems by allowing efficient execution on tens to hundreds of thousands of computational processors.

He is involved in numerous inter-agency efforts to implement advanced dynamical algorithms for global earth system modeling, and has collaborated with various institutions including the NOAA Geophysical Fluid Dynamics Laboratory on the non-hydrostatic finite-volume cubed-sphere dynamical core, the NASA Goddard Institute for Space Sciences modelE general circulation model, and the Community Atmospheric Model (CAM) at the National Center for Atmospheric Research

It is clear that Dr Putman might be just a tad 'brighter' and informed than Albanese and Bowen (combined) - thus not to be dismissed. Accordingly, perspective is vital to correct the basis of Australia's scare campaign. Australian emissions do not even rate a mention - and cannot as our emissions are insignificant due to our globally insignificant population (0.33%).
